

#### MICHAEL J. MARTIN

July's speaker Michael Martin grew up in Mequon, Wisconsin, and graduated from Homestead High School in 1977; received a BS in Animal Science from Iowa State University and a MS and PhD in Animal Science from the University of Missouri-Columbia before doing two years of post-doctoral research at North Carolina State University where he taught. Michael spent 13 years genetically engineering and cloning pigs for biotech companies. He currently manages two swine facilities with the Spring Point Project, one in River Falls and one in Huron, South Dakota and makes his home in Amery.

Michael has had Civil War articles published in America's *Civil War* and *Military Images* magazines and authored *A History of the 4<sup>th</sup> Wisconsin Infantry* and *Calvary in the Civil War*. His passion of Civil War history comes natural to Michael; his great-great grandfather was in the Fifth New Hampshire Infantry and was wounded at Gettysburg during the fighting on July 2, 1863. He is currently working on a book entitled *Break Not Their Sweet Repose* which contains biographies of every Wisconsin Civil soldier buried in the National Cemetery at Baton Rouge, Louisiana. "Those guys, most of whom died of disease, never made it home and deserve more than a footnote in history."



The 4th Wisconsin infantry was organized as infantry but two years later changed to cavalry. While its ranks were filled with men from primarily central and southern Wisconsin, Company G was raised in Hudson, Wisconsin, and included soldiers from Star Prairie, Osceola, River Falls, Rush River, Somerset and Cylon. The regiment served in the Eastern Theater during the Civil War's early months but transferred to the Western Theater (Baton Rouge, Louisiana), where it spent the remainder of the war. After the surrender of the Confederate armies in the

spring of 1865, the 4th Wisconsin was sent to Texas where the regiment was broken up by companies and deployed in various outposts along the Rio Grande River. On May 28, 1866, Wisconsin's last regiment of Civil War volunteers was mustered out at Brownsville, Texas.

Muriel Pfeifer, our past PCHS president, is a member of Daughters of the Civil War and is working on recording the information on all the Civil War Veterans buried in Polk County. If you have any information please call her 715-268-6578.



#### JEWELRY STORE ARTIFACTS

Richard and Dolores Scholz brought more of W.W. Winchester's jewelry store equipment to add to the collection. Pictured here are two pieces.

The case on the left has drawers containing watch crystals. On the top of the case is a press to insert the crystals in watches and is operated by stepping on the lever in the bottom.

On the right is a pantograph for engraving. The drawers contain with many styles of letters. By placing a stylist into the font and adjusting the machine infinite sizes of letters can be created.

# WILLIAM W. WINCHESTER

William W. Winchester, one of Polk County Historical Society's founders, moved with his parents to Wisconsin from Pennsylvania 1867. He received his education in Barron County and then took a course in a commercial college. He took up railroading and telegraphy for a year and then learned the jeweler's trade. In 1890 he moved to Amery and opened a jewelry store and at once took an interest in the business growth of the village. Winchester was a leader in every movement for the area prosperity, appointed court commissioner of the circuit court in 1902, mayor of Amery and president of the Business Men's Association in 1906. He served as justice of the peace, secretary, assessor, and clerk for the village of Amery. In1892 William married Maggie A. Gaffney. The couple had five children: Vera E., Roy C., Susie A., William W. and Mae M.

#### MAJOR JOSEPH STANNARD BAKER

One of Polk County's early colorful citizens, J. S. Baker of St. Croix Falls was second in command during the seize and subsequent death of Lincoln's assassinator, John Wilkes booth. The following is Baker's testimony at the congressional investigation of Booth's death:

- Q. Were you one of the party in pursuit of Booth?
- A. I was. I had charge of the party until we arrived at Belle Plain.
- Q. How far is that from where you found Booth?
- A. We found booth three miles from Port Royal, which is twenty-five or thirty miles from Belle Plain.
- Q. Who had command then?
- A. Colonel Conger. When we arrived at Belle Plain, in the night, I told him—he being in an experienced cavalry officer, and being acquainted with the country that he better take charge of the party, and I gave up the command to him.
- Q. Where did you first come across Booth?
- A. At Garrett's farm, three miles beyond Port Royal in Anne Arudel county, I believe.
- Q. Did you see Booth shot?
- A. I saw him fall. I was at the door of the barn and had the lock in my hand. The moment the fire was lit in the barn I opened the door in order to give him an opportunity to come out. Coloner Conger lit the fire from the side of the barn. I had charge of the door all the time we were there, and had all the conversation with booth before he was shot.
- Q. State the conversation you had with him.
- A. ....When Conger was firing the barn, the last words that Booth said were, "One more stain on the old banner." I opened the door quickly, and the first I saw of Booth he was leaning against a hay mow, which a crutch under each arm, and a carbine resting in this way at his hip. He was in the act of getting up, and dropped one crutch, and started toward the fire. He got within six or eight feet of the side of the barn, and peered all about as though he seemed to give it up... The fire was rolling over the roof. He saw the door open, and he turned and dropped the other crutch and started toward the door... I heard the report of a shot.
