


#### Robert Husband - Edward E. Husband

Edward E. Husband, a well-known editor of Polk County, was born in Flint Township, Pike County, Illinois, March 15, 1877, son of Robert and Esley (Grable) Husband, the former of English and the latter of Welsh-German descent. Robert Husband visited Polk County for the first time in 1862 and worked in one of the early sawmills at Balsam Lake. Later he enlisted in Company F, 137th Illinois Volunteer Infantry, and served six months. Subsequently he came from Illinois to Wisconsin again. In those days the region now known as Polk County was a wilderness and deer were plentiful as rabbits are at the present time. After thoroughly satisfying himself as to the desirability of this county as a place of permanent abode, he brought his family [including daughter, Nellie, mother of Marion (Park) Deaver] here in 1881 and located on a farm that now lies within the village limits of Balsam Lake. He died October 26, 1904, and his widow still survives. Edward E. Husband received a good common education at home and taught in the schools of Polk County for eight years, working on the farm during the summer vacations. After his father's death in 1904 he ran the farm for several years and in 1906 was a candidate for clerk of court, being defeated by John Davidson by a small majority. In March, 1907, he purchased the "Polk County Ledger," since which time the paper has become one of the recognized weeklies of the Northwest - an important factor in the politics of the county. The editorials are well written and the paper is newsy and readable. In politics Mr. Husband has always been a Republican. He has been twice elected justice of the peace, has served one year as school treasurer and three years, 1905-1908, as district school clerk. During the same period he was village clerk. He has always been interested in and connected with every public enterprise of a local nature and is recognized as one of the leading exponents of all that tends to the betterment of the county and village.



GOODBYE ED, AND THANKS, (Editorial in February 21, 1974 Polk County Ledger, 1<sup>ST</sup> section, 2<sup>nd</sup> page)

How do you say goodybye to an old friend? Perhaps by recalling some of those memories...

In December, 1904, he and James Ely went by train to the St. Louis, Mo., Expostion and heard President Theodore Roosevelt speak.

Somehow he met Mamie Kippen of Clear Lake who was also a schoolteacher and on June 14, 1905 they were married at the Kippen home at Clear Lake. The wedding write up in the Ledger indicates it was quite an affair with the vows said at high noon and breakfast served afterwards. The next night Ed and his bride were at their Balsam Lake home, the Jensen band from Milltown came down and about 100 relatives and friends came in, partied, ate and left about 11:00 that evening. The wedding write up said of Ed: "The groom has been one of our Polk County teachers, Ed was the first and only male teacher at Sucker Lake School and also taught in the Balsam Lake Schools] a bright, genial fellow of good business qualities and is to be congratulated on his securing such an estimable young lady for a wife."

Ed purchased the Polk County Ledger from N. E. Johnson... In a notice headed "To the Public," Mr. Husband announced: "For the seventh time in its history the Polk County Ledger comes out this week under a new proprietorship... While conscious that my lack of experience in newspaper work will be a barrier in the path to success, yet, I hope by energy and stick-to-it-iveness to be able to overcome the obstacles and publish a sheet that will be a welcome weekly visitor in many homes..."

From reading the Ledger volumes of subsequent years there comes a picture of some successes intermingled with difficulties. He was elected clerk of court and endeavored to publish the Ledger at the same time, just as later he was elected to the assembly and found that both jobs caused him to neglect the Ledger. He was defeated for a third term as assemblyman and turned his attention back to the newspaper, doing some of his best writing.

In his last editorial he wrote: "Just as a time comes into life of each and everyman to say 'Good Bye' to this world, so the time has come for the writer to say 'Good Bye' to his ownership and editorial management of the Ledger.

FORMER LEDGER PUBLISHER DIES AT 96 (The Polk County Ledger, 2<sup>nd</sup> section, 1<sup>st</sup> page)

Husband was active in county and state politics. He was assemblyman for two terms from 1926 thru 1930, was appointed clerk of court in 1917 and served thru 1926 when Walter T. Peterson was elected, was appointed register of deeds in 1941 on the death of John H. Towers and served thru 1942, he was at various times a deputy sheriff, was village clerk when the village incorporated, he served on the county board from 1916 to 1917 when he resigned to become clerk of court, served again on the board in 1940 and in 1946 he was elected county board supervisor and served thru 1952. In later years he was justice of peace for Balsam Lake village before the establishment of the county's small claim court and heard many cases. He was a member of the draft board in both World Wars and was clerk of the draft board following WWII. He held offices in the county Republican party and was an active worker in it.






